

Some Solutions to Improve the Effectiveness of Legal Education for Students of Vietnam-Korea University of Information and Communication Technology

The school focuses on innovating the content and diversifying forms of legal education, bringing the dissemination of legal education in the school to be developed stably, effectively and in depth.

I. INTRODUCTION

Over the years, our Party and State have issued many guidelines, policies and legal documents to create a legal basis for legal education in the education sector (Directive No. 32-CT/TW dated 09/12/2003, Decision No. 409/QĐ-TTg, Decision 705/QĐ-TTg, Decision 3957/QĐ-TTg...) in order to improve the quality of legal education in schools.

Implementing the Party's documents and the State's laws on legal education, in recent years, universities have directed, organized and implemented legal education for students with a focus and focus associated with the specific training professions of each school. Like other training institutions, the Vietnam-Korea University of Information and Communication Technology has organized the dissemination and education of law through activities and programs of formal education, extracurricular education and achieved certain results. In addition to the achieved results, legal education at the Vietnam-Korea University of Information and Communication Technology is also in the general situation of other non-law universities. That is the content and curriculum that have not been completed and regulated; legal research materials are still limited, and the duration of teaching the subject is small. The equipping of legal knowledge, awareness and law-abiding habits for students in the university has not been highly effective... Therefore, the Vietnam-Korea University of Information and Communication Technology needs to have really effective solutions to improve the quality and effectiveness of legal education for students is a really urgent requirement in the new situation.

II. CONTENTS.

1.1. The current situation of teaching Law at the Vietnam-Korea University of Information and Communication Technology

The Vietnam-Korea University of Information and Communication Technology has always determined that legal education for students must ensure the common goal of forming and expanding legal knowledge for students. Legal education aims to foster and develop legal beliefs for students, practice law-abiding habits and behaviors for students so that they can well perform the rights and obligations of citizens in all fields of social life.

In addition to ensuring the general requirements of legal education for students, the Vietnam-Korea University of Information and Communication Technology also sets goals to ensure that job positions meet the output standards of each training major of the university. The goal of the university is to train future engineers and graduates with political qualities and professional ethics, equipped with basic knowledge of law in general, law in specialized fields in particular; capable of working independently and creatively, solve specialized issues as well as the responsibility of "Living and working in accordance with the Constitution and law".

As with other training institutions, in recent years, although legal education has been focused, innovated in content, and diversified in form, the effectiveness of this work is still unclear and formal. Although the forms of legal education have been applied quite diversely and richly, in general, the effectiveness is still not high the

content of legal education for students is still heavy on the dissemination of legal provisions, which has oriented students to practice behavioral skills, skills in applying the law to solve life's problems, however, have not met the actual needs.

The practice of teaching law at the Vietnam-Korea University of Information and Communication Technology is also in the general situation of other non-law universities. That is the content, curriculum has not been completed and the rules and legal research materials are still limited, the duration of teaching the subject is too small (02 credits) while the content needs to be retransmitted relatively much. As a general subject, the position of the subject is overlooked. Students' positivity and self-discipline in learning are not high. The coordination between family, school and society in legal education for students is not really close.

In addition, legal education for students Vietnam-Korea University of Information and Communication Technology also faced many difficulties due to the explosion of unofficial information with complex content. The opportunity for students to access information about legal education is still limited, so the mechanism of "self-defense", "control" and "screening" of information is still low, therefore, they will have to absorb naturally, more or less, consciously or unconsciously those negative aesthetic tendencies.

1.2. Some solutions to improve the effectiveness of teaching law at the Vietnam-Korea University of Information and Communication Technology

In order to improve the effectiveness of legal education in Vietnam-Korea University of Information and Communication Technology It is necessary to synchronously combine the following solutions:

a. Promoting students' positivity and self-discipline in the process of legal education

Students are a progressive social class, systematically absorbed the quintessential knowledge of humanity in general and of the country in particular. They are creative, positive, agile, and dynamic in learning, research, and application as well as in social relationships. Students have the ability and desire to become good citizens, qualified workers, therefore they are always inquisitive, curious, willing to learn new things and often have a high determination to express their will.

Quality Legal Education of students depends on the student's own activeness in learning, training and cultivation. Educating students to promote positivity, self-discipline, build motivation to study, practice correctly and regularly improve attitudes, responsibilities, and strictly abide by the law requires the Board of Directors of schools, specialized departments and faculties to regularly develop plans, measure Legal Education for students.

Currently, the use of social networks such as Facebook, Zalo, Youtube, tiktok.... is common. However, due to the diversity of information and the abetment of hostile forces against sabotage, a lot of unofficial information contains reactionary content. Therefore, on the one hand, the university needs to promote the application of information technology and the internet in the process of propaganda, legal education, union activities, classes, movement organization and student management, and at the same time focus on fostering and training staff to improve their professional skills. especially the network administration for officials in charge of websites, providing practical solutions to control and limit the negatives of cyber information, for example, filtering out black websites and preventing them, deleting reactionary websites; strengthen the work of information, guidance, exchange, and preparation of legal questions and answers on the website of the University and its affiliated units to promptly answer information and questions of students. Instruct students on how to use official websites and how to check the information. The school needs to orient and promptly handle information that deviates from the standard through the school's email, regularly review and check the social networking sites managed by the school to avoid copying and forging that affects the perception of students and the reputation of the school.

b. Legal education in training in accordance with the practice associated with students' majors

In order for legal education to be highly effective, legal education in training must be consistent with real life, and legal dissemination and education must be associated with the nature, professional characteristics and majors of students. Legal education for students must be in accordance with practical requirements, associated with students' majors. This is a requirement that reflects the trend of the times, all activities of the legal education process must closely follow and be closely associated with the practice of building and defending the country, the practice of professional activities of students after graduation.

c. Diversifying and innovating forms and methods of legal education for students

In order to carry out the innovation in education in general and legal education in particular, it is necessary to implement the motto of diversifying forms of education through the use of some forms of legal education as follows:

First, direct teaching in class: This is the most basic and important form of all forms of legal education, which has a direct effect on the educational object about the system of knowledge, theory and practice, thereby forming legal awareness for students.

Second, self-study and self-study about the law: Along with participating in learning according to the prescribed

program, it is very useful for students to self-study and learn about the law on their own. To carry out this activity, students must self-study and improve their understanding of the law in an appropriate and practical way. In addition, in order to promote the strengths of this form, it is necessary to have the guidance of lecturers and create all necessary conditions in terms of materials, time, application of measures to encourage learning, encourage students to be enthusiastic, eager to learn, and learn legal knowledge by themselves.

Third, legal education through extracurriculars: It can be said that this is a very vivid form of legal education. Implementing this form will be more complete than the legal knowledge students have learned in class, thereby improving the sense of law observance for learners.

Fourth, legal education through practical activities: This is a very necessary and important form of legal education like extracurricular education, thereby implementing the motto of learning in tandem with practice, theory associated with practice that should be implemented in schools. thereby improving the quality of students' learning.

Fifth, legal education through the media and media: The media and media have a great effect in raising the level of awareness in all aspects for students. Compared to the form of law teaching, this is also a basic and highly effective form of legal education, but it is only implemented under certain conditions in terms of facilities for teaching and learning and time funds...

d. Improving the quality of law lecturers

Stemming from the actual situation of the work Legal Education, we see that building a team of lecturers Legal Education being qualified and capable is now a very necessary and urgent job. This team plays an important role in bringing efficiency to work Legal Education so they must ensure that they have expertise, solid knowledge, pedagogical skills and love for the profession. Vietnam has a written legal system, so the law is amended and supplemented regularly to suit practical requirements. Accordingly, legal education workers need to regularly update their legal knowledge and participate in training courses to improve their professional knowledge. Because "content determines form", only when lecturers are firm in professional knowledge, practical knowledge and pedagogical skills, it will be easier to innovate and apply many teaching methods and achieve higher results.

e. It is necessary to strengthen close coordination between families, schools and society in legal education for students

Families and schools need to closely coordinate with each other in legal education because these are the basic environments that form students' personalities. The school (teachers and classmates) is the one who greatly influences the process of forming students' personalities. The school environment is also a place where students experience awareness and attitudes to communicate with the community. The school is the first place where students are free to go beyond the protection and control of their parents, they must learn to make their own decisions, think for themselves and take responsibility for their actions. This is also the stage, which according to psychological research is "full of ambiguity, frustration and contradiction" and when overcoming these disorders, students are able to mature, be independent, be able to give/receive and relate to others.

f. Strengthening material conditions to ensure to ensure the quality of legal education.

Funding and resources are necessary conditions to ensure the organization and implementation Legal Education for students. Guaranteed funds and abundant resources will create the best conditions for the implementation of the work Legal Education and accomplish educational goals. Therefore, to manage and organize the implementation of the Legal Education for students in an effective, demanding way school constantly promote the increase of funding and resources for work Legal Education in-depth and highly efficient operation (including funding sources and management and use of funds to ensure the implementation of Legal Education), material foundations and working facilities in service of this work (textbooks, textbooks; dissemination materials, Legal Education, law bookcases, teaching equipment and other material means).

g. Strengthen coordination with judicial agencies in providing legal education for students

Strengthen coordination with local judicial agencies to organize students to attend court hearings for juvenile cases of crimes related to contents such as school violence, traffic safety violations, fraudulent appropriation of property through multi-level marketing models, etc. This form is vivid, attractive and attractive to viewers, the content is specific to each case, so it is easy for viewers to absorb and remember for a long time.

h. Strengthen the review, evaluation and learning of experiences in legal education

When implementing the work Legal Education for students to stay in Vietnam-Korea University of Information and Communication Technology it is necessary to pay attention to the work of summarizing, evaluating and rewarding. Specifically, the school should maintain the development of the plan Legal Education annually, there are sanctions binding legal liability for units and individuals responsible for implementation; strictly implement the reporting regime according to the plan and evaluate the implementation results. The school's Emulation and Commendation Council shall base itself on the results and efficiency of its work Legal Education

students to serve as a basis for requesting commendations and rewards for units and individuals that perform their tasks well.
